STUDENT TECHNOLOGY PLAN AND NETWORK ACCESS

SDUHSD provides students with access to computer equipment, software, and network services. These tools are for learning, collaboration, and educational research related to the district curriculum. All technology and network usage must be consistent with these purposes, the <u>Acceptable Use Policy</u>, and all provisions of law governing the actions of the user. Students are expected to use any district technology equipment, software, and network services only for assignments/projects that are assigned by their classroom teachers.

➤ Consequences for individuals violating the Acceptable Use Policy vary depending on the nature and seriousness of the violation. Consequences might include conference, loss of computer/technology access, suspension and/or expulsion.

ATTENDANCE

ABSENCE (STATE CLASSIFICATION)

1. STATE EXCUSED ABSENCES-EXCUSED

Absences due to illness, dental, medical appointments, death in the family, and official school business are the only absences for which a state excused State Absence and Admittance Report will be issued. Reference: Ed. Code 46010. Credit will be issued for work made up for an excused absence.

ILLNESS/INJURY Students returning from extended absences due to ILLNESS or INJURY will be required to submit documentation according to the District's Health Office Guidelines. • Medical documentation is required for any absence due to illness that extends 5 consecutive school days or more; documentation must be provided before the absence will be cleared.

2. UNEXCUSED/VERIFIED ABSENCES

Absences other than those listed in (1) above are considered an unexcused/verified absence and make up work may be permitted at the discretion of the teacher. Examples of these consist of out of town, family business, car trouble, and absences not related to illness or medical appointments.

3. SCHOOL EXCUSED ABSENCES

Absences for school sponsored activities will be school excused and make-up work may be permitted.

4. UNVERIFIED ABSENCES

Absences not covered under STATE EXCUSED or SCHOOL EXCUSED classifications and absences for which no verification is received will be considered a truancy and make-up work is not permitted.

TRUANCIES

Students with unverified absences can expect disciplinary action and/or a referral to the SART/SARB process. For specific consequences, refer to the Progressive Discipline Plan.

TARDIES

Tardies, like absences, adversely impact students' education and increase the chance of failure. Tardies also interrupt the classroom and interfere with the learning process. Please see Progressive Discipline Plan for consequences related to the school-wide tardy policy.

CLEARING ABSENCES/TARDIES

All absences and tardies must be reported by the student's parent or legal guardian within 48 hours by phone, email, or a note, otherwise it is considered a truancy. Please email lcattendance@sduhsd.net, or call the attendance office message line at (760) 436-6136 ext. 6008 (available 24/7). Messages can be left in Spanish at ext. 6010.

LEAVING CAMPUS/OFF CAMPUS PASSES

Off Campus Passes

The LCCHS campus is a closed campus for Freshman, Sophomores, and Juniors. Only Seniors are permitted to leave campus during lunch. No student is allowed to leave campus at brunch/break.

Off Campus Passes can be requested via email, written and signed note, or by calling the Attendance Office at (760) 436-6136 ext. 6008 (available 24/7). Press "2"

During Class Hours: All students must have an off campus pass from the Attendance Office to leave campus. Students need to pick up their off campus pass in the Attendance Office before school, during break, or during lunch. Students may not leave class to pick up their pass; they must pick it up in advance of class starting. Any student who leaves campus without obtaining a school off-campus pass prior to departure can face progressive disciplinary action.

During Lunch Hour: Seniors are allowed off campus for lunch, but may not loiter and/or occupy the parking lot. Underclassmen who leave campus during lunch will be subject to progressive discipline and if applicable, may lose parking permit privileges.

Release Home: Students who become ill or injured at school need a pass to the Health Office. The Health Tech will contact their parent/guardian for pick-up and/or provide permission for the student to drive home (if applicable/safe).

Medical Appointments: Requests to leave for medical/dental appointments must be supported by a call to the Attendance Office personnel prior to school in the morning. Students must obtain an off campus pass before leaving for their appointment. Failure to obtain an off-campus pass will result in a truancy.

MAKE-UP WORK

It is the responsibility of the student to contact the teacher for make-up work when make-up privileges have been granted.

VISITORS / GUESTS

LCCHS is a closed campus. All visitors/guests must have prior approval and sign in through the Administration Office before entering campus. All visitors must present a driver's license/photo ID.

VISITORS/GUEST PARKING

All visitors/guests need to park their vehicles in the designated visitor parking spaces and check-in at the administrative office for a visitor parking permit. Vehicles parked in unauthorized spots will receive a parking citation.

BEHAVIOR EXPECTATIONS

LA COSTA CANYON HIGH SCHOOL – Discipline Policy

All LCC students and parents receive an annual Discipline Policy Notification and through the district data confirmation process and completion of the data confirmation process certifies that students and parents are familiar with key school rules and are aware of the discipline policy as a whole. GENERAL SCHOOL RULES/EXPECTATIONS

- Students will follow the SDUHSD Academic Honesty Policy.
- Students will treat peers and all school staff with respect.
- Students will not use profanity.
- Students will not commit vulgar/obscene acts, make inappropriate displays of affection, and/or be in possession of obscene/vulgar material.
- Willful defiance of authority or disruption of academic, athletic, or school sponsored activities is not acceptable.
- Students will not harass or intimidate students or staff.
- Students will not engage in conduct constituting sexual harassment and or sexual assault.
- Students will not fight.
- Students will not possess, sell, or furnish controlled substances (drugs or alcohol).
- Students will not possess or be under the influence of alcohol, drugs, or paraphernalia at school or at school events.
- Students will not steal, deface, or vandalize school property.
- LCC is a closed campus for Freshman, Sophomores and Juniors. NO visitor passes during school hours.
- Students *may not* loiter in vehicles or parking lot at brunch, lunch or during instructional time.
- Students are required to follow the Appropriate Use Policy at all times with technology. The use of personal technology is at the discretion and supervision of each classroom teacher.
- Due to safety concerns, mobile food deliveries are prohibited at LCC at any time during school hours.
- Skateboarding on school grounds is prohibited. The use of motorized vehicles (i.e. scooters, E-bikes, segways, etc.), is prohibited on campus to ensure the safety of pedestrians.

ACADEMIC HONESTY POLICY

Honest behavior is an expectation for all students in the San Dieguito Union High School District. The purpose of this regulation is to create and maintain an ethical academic atmosphere. Specific types of academic dishonesty, which will not be tolerated, are defined below:

- Cheating on Tests Any intentional giving of or use of external assistance relating to an examination, without the express permission of the teacher. This includes looking at another student's paper, sharing answers, or copying another student's paper.
- **Fabrication** any intentional falsification or invention of data, citation, or other authority in an academic exercise.
- **Unauthorized Collaboration** While collaboration is often encouraged, unauthorized collaboration is not permitted.
- **Plagiarism** Any intentional representation of another's ideas, words, or works as one's own. Plagiarism includes the misuse of published material, electronic material, and/or the work of other students. The original writer who intentionally shares his/her paper for another to copy, without the permission of the teacher, is also engaged in plagiarism.
- Alteration of Materials Any intentional and unauthorized alteration of student, teacher, or library materials.
- Forgery any unauthorized signing of another person's name to school related documents.
- **Theft** any theft of materials.
- Transfer of Unauthorized Materials any giving or selling of unauthorized materials.

Progressive Consequences for Academic Dishonesty

Any alleged violation of this policy will be investigated thoroughly and appropriate disciplinary measures will be taken consistent with Board policy. Depending on the severity of the offense *one or more* of the following consequences may occur:

- Referral to the assistant principal and the parent/guardian will be contacted.
- Loss of all credit for the assignment or test with no makeup permitted.
- Placement on probation with a contract (in the class of the infraction) for the remainder of that class.
- Receipt of a "U" in citizenship for the current grading period.
- Violation on a school administered national or state examination will result in a district code of conduct violation.
- Dropped from the class with no credit.
- Suspension from school.
- Removal from all elected or appointed leadership positions for the remainder of the school year.

DRESS CODE

Per <u>District Policy</u>, student clothing must not present a health or safety hazard, or must not cause a disruption to the education environment. Please reference <u>Dress Guidelines</u> on the LCC website under Key Info for specific information. Administration reserves the right to implement progressive discipline action to address dress code infractions. Also, administration reserves the right to alter/modify the dress code as styles change or clothing becomes a safety issue.

NONDISCRIMINATION

It shall be the policy of the San Dieguito Union High School District to prohibit discrimination on the basis of sex, disability, race, color, national origin, religious creed, age, marital status, or sexual orientation in the educational programs and activities which it operates.

INTENTIONAL HARASSMENT AND HATE VIOLENCE

Intentional harassment is defined as threats or intimidation directed against a student or group of students that is sufficiently severe or pervasive that it materially disrupts class work, creates disorder, and invades the rights of that student or group of students. Hate violence is defined as any act punishable under California Statutes that interferes with the exercise of an individual's civil rights, defacing or damaging personal property or felonies against persons because of the victim's race, color, religion, nationality, or ancestry. (Penal Code Sections 442.6, 442.7, and 442.7.75.)

Students are subject to suspension and/or expulsion for harassment and/or hate violence when other means of correction have failed to bring about proper conduct or if the student's presence causes a continuing danger to physical safety or threatens to disrupt the educational process.

SEXUAL HARASSMENT

Definition: "Sexual harassment" means unwelcome sexual advances, requests for sexual favors, and any other verbal, visual, or physical conduct of a sexual nature made by any person from or in the work or educational setting under any of the following conditions:

- Submission to the conduct is explicitly or implicitly made a term or a condition of an individual's employment, academic status, or progress.
- Submission to, or rejection of, the conduct by the individual is used as the basis of employment or academic decisions affecting the individual.
- The conduct has the purpose or effect of having a negative impact upon the individual's work or academic performance, or of creating an intimidating, hostile, or offensive work or educational environment.
- Submission to, or rejection of, the conduct by the individual is used as the basis for any decision affecting the individual regarding the benefits and services, honors, programs, or activities available at or through the educational institution.
- As it relates to students, subjects any pupil to discrimination on the basis of sex, including sexual harassment, in any district program or activity.

Other types of conduct which are prohibited in the district and which may constitute sexual harassment include:

- Unwelcome leering, sexual flirtations or propositions.
- Unwelcome sexual slurs, epithets, threats, verbal abuse, derogatory comments or sexually degrading descriptions.
- Graphic verbal comments about an individual's body or overly personal conversation.
- Sexual jokes, stories, drawings, pictures or gestures.
- Spreading sexual rumors.
- Teasing or sexual remarks about students enrolled in a predominantly single-sex class.
- Touching an individual's body or clothes in a sexual way.
- Purposefully limiting a student's access to educational tools.
- Cornering or blocking of normal movements.
- Displaying sexually suggestive objects in the educational environment.
- Any act of retaliation against an individual who reports a violation of the district's sexual harassment policy or who participates in the investigation of a sexual harassment complaint.
- Sexual harassment is prohibited against members of the same sex as well as against members of the opposite sex.
- School consequences for any instances of sexual harassment will be strictly imposed.

TOBACCO/ELECTRONIC CIGARETTE FREE FACILITY

In the best interest of students, employees and the general public, the Board of Education prohibits the use of tobacco/electronic cigarette products/devices at all times on district property and in district/personal vehicles. This prohibition applies to all employees, students, visitors and other persons at any school or school sponsored activities or athletic event. It applies to any meeting on any property owned, leased or rented by or from the district. In addition, law enforcement will be contacted to address violation of the law.

ALCOHOL, DRUGS, NARCOTICS, TOBACCO AND NICOTINE

The use, consumption, sale, possession, arranging or negotiating to sell, or being under the influence of alcoholic beverages, drugs, narcotics or nicotine is strictly prohibited and punishable by suspension or recommendation for

expulsion. This pertains to students on school grounds, or when under the authorization or direct supervision of school personnel at school events off campus, or while in transit to or from school or school activities. In addition, law enforcement will be contacted to address violations of the law.

**Two or more days of suspension from school and/or participation in SDUHSD's ATOD program will result in a thirty day non-participation for extracurricular activities and/or co-curricular activities to include athletics, dramatic productions, or other school related events and/or activities.

SAFE SCHOOL

Students and staff members are entitled under the California State Constitution to attend schools that are safe, secure, and peaceful. The presence of weapons or replicas contribute to a climate of fear and disrupts the learning environment of the school. Replicas of weapons, whether they be toy firearms, theatrical props, cap guns, starter pistols or replicas of other deadly weapons, have no place in the school environment and may lead to progressive discipline.

Weapons

- Students utilizing any dangerous or deadly weapon (including replicas) in a threatening manner or to incite
 fear, inflict injury, or disrupt the educational process are subject to suspension/expulsion. This also includes
 social media postings.
- Any SDUHSD employee or district contracted transportation service representative may remove from the
 possession of any student any firearm, knife (including Swiss army, pocket, etc.), explosive or other dangerous
 objects, while the student is on school premises or engaged in any school-sponsored activity or going to or
 returning from school or otherwise under the authority of the school.
- This act shall be reported to the principal/designee. The student will surrender all dangerous objects or be subject to disciplinary action for such refusal. Parents and appropriate law enforcement officials shall be notified by the principal/designee of the taking of weapons and the disciplinary action followed. Students are subject to suspension or expulsion for possessing illegal weapons upon a first offense. Illegal weapons will be turned over to the police department as evidence.
- **Search and Seizure**: To maintain order on school premises, it may be necessary at times to conduct searches of vehicles, personal property, or require students to submit to searches for weapons, drugs, or contraband.

VEHICLE AND PARKING LOT REGULATIONS

START SMART

According to SDUHSD Board policy, all students must attend a CHP Start Smart class in order to be eligible to obtain a parking permit. Visit Start Smart for more information.

PARKING PERMITS

Student parking for juniors and seniors is available in the student parking lot only (first come first serve) and all students must have valid parking permits to utilize the lot. More information on parking permits is available on the LCC website under Key Info/Parking, or <u>click here</u>.

TEMPORARY DAY PARKING PASS (Only for Students w/ Valid Parking Permits)

A day parking pass is available for students with valid parking permits who need to temporarily drive a non-permitted vehicle to school. Students must obtain the day parking pass in the administration building and display it in their alternate vehicle. Otherwise, the non-permitted vehicle will be subject to a parking citation.

PARKING CITATIONS

Cars parked without a parking permit and/or incorrect designated spots will receive a parking citation.

PARKING LOT RULES AND REGULATIONS

- Parking permits are provided to 11th and 12th grade students.
- LCC is a closed campus for 9th, 10th and 11th grade students. Only 12th grade students are permitted to leave campus during lunch. Drivers and passengers must have a current student I.D. card to leave campus
- Students may not loiter in vehicles or parking lot at brunch, lunch or during instructional time.
- Vehicles parked on campus are subject to search.
- Neither SDUHSD or LCC is responsible for any damage or loss to a vehicle or personal property.
- Students must park in areas clearly identified as "Student Parking". Students are *not* allowed to park in marked, RED, STAFF or VISITORS/RESERVED.
- Parking permits are not transferable between vehicles. Parking sticker must be affixed to the driver's side windshield.
- Maximum speed limit on school property is 15 MPH.
- Students who don't have a valid permit and park on campus will receive a citation.
- Vehicles parked illegally may be towed at the owner's expense.
- Violation of the above parking regulations may result in a parking citation.
- Any student who receives more than one citation will meet with administration after the second citation and parents will be contacted.

• If students continue to receive citations after meeting with administration and parent contact, students may receive progressive disciplinary action to include the possibility of removal of parking privileges in the student lot and/or suspension.

LCC Discipline Plan 2021-22

LCC takes pride in promoting academic, social, and emotional success by implementing a discipline plan to ensure the safety of each student. Note that repeat offenses lead to more serious disciplinary responses than the original violation. The administration reserves the right to objectively determine consequences based on the seriousness of a particular infraction, and the previous discipline record of the student who commits the offense. In addition, the administration reserves the right to implement Restorative Practices on a case by case basis. Failure to comply with assigned consequences may result in suspension from school and school activities.

Students missing assigned detentions will be assigned a Saturday school. Students missing Saturday school will be assigned an additional Saturday school. Failure to attend will result in one full day in-house suspension.

IMPORTANT NOTE: Any violation of school rules during end of the year senior activities will result in loss of the privilege to participate in graduation ceremonies.

APPENDIX

DISTANCE LEARNING POLICIES/RECOMMENDATIONS

Just as on campus learning, distance learning requires that students adhere to a prescribed set of rules and behavioral norms. These behavior expectations are designed for all students in the San Dieguito Union High School District. Please take a moment to review these policies and recommendations to ensure that you and your student know the school rules and possible disciplinary actions. Any alleged violation of these expectations/ policies will be investigated thoroughly and appropriate disciplinary measures will be enforced if necessary. SDUHSD provides students with access to computer equipment, software, and network services. These tools assist learning, collaboration, and educational research related to the district curriculum. All technology and network usage must be consistent with these purposes, the Acceptable Use Policy, and all provisions of law governing the actions of the user. Students are expected to use any district technology equipment, software, and network services only for assignments/projects that are assigned by their classroom teachers. Consequences for individuals violating the Acceptable Use Policy vary depending on the nature and seriousness of the violation. Consequences might include video/phone conference, loss of computer/technology access, suspension, and/or expulsion.

Policies

- You MUST use your SDUHSD email account for class to work and communicate with teachers and this email is needed to access your classes Google Classroom
- Understand that attendance contributes to your success and the expectation is that you attend. If for any reason you miss class, it is student's responsibility to reach out to the teacher to determine what is missed
- Be on time for class, as roll will be taken for each period
- Be present and available as prescribed by your teacher's syllabus.
- Wear attire acceptable for school:
 - Attire, accessories, and belongings (hats, jewelry, phones, binders, stickers) <u>may not</u>: advertise, promote, or glamorize any of the following: drugs, alcohol, tobacco/vape products, violence, gang

- affiliation, weapons, inappropriate or sexually suggestive language or symbolism, degrade or demean any ethnic background, national origin, religious belief, gender, gender orientation, sexual orientation, or disability.
- Clothing <u>must</u> be sufficient to: conceal undergarments at all times, in both seated and standing
 positions. Clothing should completely conceal buttocks and the majority of the chest and abdomen at
 all times, in both seated and standing positions. Opaque leggings and sheer garments are permitted, as
 long as other clothing would still meet dress code criteria if the sheer garment was removed.
- Jewelry, accessories, and other belongings that, in the opinion of the staff, distract from the educational goals of LCC by attracting undue attention or posing a potential threat to the safety of others are **not permitted**.
- Engage in your classes, following the instructions and directions given by the teacher
- Position your camera angle so your teacher can see your face
- Notify school personnel immediately if you encounter any technical issues
- Follow the LCC Student Handbook
- Use equipment as outlined in the <u>Acceptable Use Policy</u>.
- Login credentials must not be shared. Sharing of login information violates other students' and teachers' rights to confidentiality and could allow class participation by unauthorized persons and/or lead to disruptive behaviors that detract from a productive and positive learning environment
- Students who are disruptive and/or "trespass" Google Meet sessions at LCC or other SDUHSD schools will
 receive appropriate consequences in accordance with the LCC Student Handbook
- Google Meet virtual instruction is designed for students. To prevent disruptions to the learning environment, parents/guardians should not actively participate in Google Meet sessions, although parents/guardians may assist their child with technology and/or remain nearby
- Do not video record, audio record, photograph, live stream, or transmit in any other way any part of a Google
 Meet, including not posting on any social media platform
- Any confidential or personally identifiable information related to students participating during Google Meets should not be collected, discussed or shared

Recommendations

- See something, hear something, sense something, say something. If you or someone you know is in need of social/emotional support, you **MUST** reach out to a trusted adult or call 911 for immediate concerns.
- Be respectful to your classmates and your teacher at all times
- Create a space and dedicated time for learning that is free from distractions
- Seek help when needed (teachers, counselors, principals and all other adults)
- Sign into the Google Classrooms daily- to be successful, keep connected
- Use Google Calendar to organize classes
- Demonstrate learning with completion of all assignments
- Communicate with your teacher, work with feedback to help make you more successful
- Reach out to your teachers if you feel overwhelmed or frustrated
- Collaborate with your peers, using respectful language and behaviors at all times
- Make sure you support each other in this way of learning, it is all new for everyone
- Be patient with yourselves and your teachers- we are all learning together!
